	Finance Committee, Mr. Perez – The February 16, 2021, meeting was canceled. Mrs. Perry sent a summary of the monthly financial reports, annual tax rate resolution, forecast adjustments, and excess cost applications to all members. The next meeting is Tuesday, March 16, 2021.

I designed "Greed" through my main mediums, photography, and photoshop. I have finished five of the seven sins and am excited to continue my series, which I plan on entering in the Governor's show. I have found that portraying inanimate ideals with various tangible elements, human expressions, and vivid colors is a thought-provoking and fascinating task."

TC Swim and Dive: The swim and dive team have had a successful season thus far. Junior Cole Eisenhower qualified for two individual events at districts. Read to Succeed: I want to recognize the Columbian students who volunteer with the Read to Succeed
